## 5.1 Extinguishing media:

Dry chemical powder, carbon dioxide, pulverized water and protein based foam.

### **5.2 Special hazards arising from the substance or mixture:**

The product can, when heated, also melt and flammable decomposition products can be generated. In a fire, decomposition products like carbon black, carbon monoxide, carbon dioxide , gaseous hydrocarbons and nitrogen containing products can be generated in various concentrations depending on the combustion conditions. Also corrosive gases and trace quantities of formaldehyde.




